

Mango Mark: Privacy Policy

Mango Mark’s mission is to “Empower people to Create, Share and Grow new knowledge and Links”. Central to this mission is our commitment to be transparent with you about the data we collect about you and how it is used and shared.

By using our Services, you consent to our use of your data under this Privacy Policy.

Your privacy is very important and we take it seriously. This Privacy Policy describes “Mango Mark” policies and procedures on the collection, use, disclosure, and sharing of your information when you using our all Services. Maintaining your trust is our top priority, so we adhere to the following principles to protect your privacy:

- We protect your personal information and will be provide it to third parties: (1) where it is necessary to carry out your instructions; (2) as reasonably necessary in order to provide our features and functionality to you; (4) when we reasonably believe it is required by law (5) as necessary to enforce our User Agreement and policies or protect the rights, property, or safety of “Mango Mark”, our Members and Visitors, and the public.
- We continuously implemented appropriate security safeguards designed to protect your information in accordance with industry standards.

Information Collection and Use

Depending on which Services you use, we collect different kinds of information from or about you.

- Things you do and information you provide.(User-Provided Information)
- Things others do and information they provide.
- Your networks and connections & Messages
- Posting and Uploading

- Information about payments and Donations.
- Your Device and Location
- Information from websites and apps that use our Services.

- Information Collected Automatically(When you use the Service, we use persistent and session cookies, for information on cookies, please see below)
- Other

Our Services are dynamic and we often introduce new features, which may require the collection of new information. If we collect materially different personal data or materially change how we use your data, we will notify you and may also modify this Privacy Policy.

And we as “Mango Mark” uses information we collect to analyze how the Service is used, diagnose service or technical problems, maintain security, personalize content, remember information to help you efficiently access your account, monitor aggregate metrics such as total number of visitors, traffic, and demographic patterns, and track Users Content and users as necessary to comply with the Acts and other applicable laws.

Why we Collect Information

- We use all of the information we have to help our users/members to create a better customized service,
- Provide, improve and develop Services.
- We conduct surveys and research, test features in development, and analyze the information we have to evaluate and improve products and services, develop new products or features, and conduct audits and troubleshooting activities.
- Communicate with you.
- Show and measure ads and services.
- Promote safety and security.

Cookies, Web Beacons and Other Similar Technologies

We use cookies and similar technologies (e.g., web beacons, pixels, ad tags and device identifiers) to recognize you and/or your device(s) on, off and across different Services and devices. Cookies are small pieces of text used to store information on web browsers. Cookies are used to store and receive identifiers and other information on computers, phones, and other devices. Other technologies, including data we store on your web browser or device, identifiers associated with your device, and other software, are used for similar purposes. In this policy, we refer to all of these technologies as “cookies.”

We use cookies if you have a “Mango Mark” account, use the “Mango Mark” Services.

Why do we use cookies?

Cookies help us provide, protect and improve the “Mango Mark” Services, such as by personalizing content, tailoring and measuring ads, and providing a safer experience. While the cookies that we use may change from time to time as we improve and update the “Mango Mark” Services, they generally fall into the below categories of use:

- Authentication and security
- Security, site and product integrity
- Marketing/Advertising, insights and measurement
- Site/product features and services
- Performance
- Advertising
- Analytics and research
- Other (We are constantly innovating to improve our Services, which means we may create new ways to collect information on the Services.)

Third Party Analytics and Advertising

“Mango Mark” may allow third parties to help us collect and analyze information about your use of the service, generate aggregate site usage statistics and provide content sharing services to support the Service. These third parties may also use cookies and similar technologies to collect similar information about your use of the Service. “Mango Mark” does not control the third parties’ use of such technologies and their use is governed by those parties’ privacy policies.

“Mango Mark” may also allow third-party ad servers or ad networks to serve advertisements on the Service and on third-party services. These third-party ad servers or ad networks use technology to send, directly to your browser, the advertisements and links that appear on “Mango Mark”. They automatically receive your IP address when this happens. How We Share Your Information

“Mango Mark” may share your information with third party service providers for the purpose of providing the Service to you, such as payment processors, email service providers, and providers of technical infrastructure (such as servers or databases co-located with hosting providers), engineering, or other support. We may also share your information with third parties offering combined services with “Mango Mark.

As we develop our business, we may buy or sell assets or business offerings. Customer, email, and visitor information are generally among the transferred business assets in these types of transactions. We may also transfer or assign such information in the course of corporate divestitures, mergers, or dissolution.

We may share or disclose your information with your consent, such as if you choose to sign on to the Service through a third-party service. We cannot control third parties’ use of your information.

We may disclose your information if we are required to do so by law, or if we believe in good faith that it is reasonably necessary to (i) respond to claims asserted against us or to comply with legal process (for example, subpoenas or warrants), (ii) enforce or administer our agreements with users, such as the Terms of Service; (iii) for fraud prevention, risk assessment, investigation, customer support, product development and de-bugging purposes, or (iv) protect the rights, property or safety of “Mango Mark”, its users, or members of the public.

We may aggregate and/or anonymize information collected through the Service so that the information does not identify you. We may use aggregated, anonymized, and other de-identified information for any purpose, including for research and marketing purposes, and our use and disclosure of such information is not subject to any restrictions under this Privacy Policy.

How We Protect Your Information

“Mango Mark” uses a variety of physical, managerial, and technical safeguards to preserve the integrity and security of your information, based on the sensitivity of the information. We cannot, however, ensure or warrant the security of any information you transmit to “Mango Mark” or guarantee that your information on the Service may not be accessed, disclosed, altered, or destroyed by breach of any of our physical, technical, or managerial safeguards.

Legal Disclosures

It is possible that we will need to disclose information about you when required by law, subpoena, or other legal process or if we have a good faith belief that disclosure is reasonably necessary to (1) investigate, prevent, or take action regarding suspected or actual illegal activities or to assist government enforcement agencies; (2) enforce our agreements with you, (3) investigate and defend ourselves against any third-party claims or allegations, (4) protect the security or integrity of our Service (such as by sharing with companies facing similar threats); or (5) exercise or protect the rights and safety of MangoMark, our Members, personnel, or others. We attempt to notify Members about legal demands for their personal data when appropriate in our judgment, unless prohibited by law or court order or when the request is an emergency. We may dispute such demands when we believe, in our discretion, that the requests are overbroad, vague or lack proper authority, but we do not promise to challenge every demand.

Your Responsibility

Users may make certain information or contents (including but not limited to biographical data, photos and videos) available on the website. **Users are wholly responsible for all such information and contents**, including information that reveals race, ethnic origin, sexual orientation, political opinions, religious or philosophical beliefs, trade union membership or that concerns an individual’s health.
